Proposed grades are K thru grades 4. Grades 5-8 will be recommended to attend Fulton Virtual Summer School. Each grade band will have four teachers with 10 students in each class. Interested teachers will complete and application proving interest. Once teachers have showed interest by filling out the application, we can assign placement and appointments. Students in need of Summer Program Intervention will be sent an invitation. Daily Breakfast and Lunch will be provided. Parents must supply transportation. Teachers will be paid the hourly rate for Title 1 and enrichment activities will be paid out of the local school budget.
